
to further build HITS as the country’s largest owner/operator of equestrian events.

AHC Releases National Economic Impact Results

The American Horse Council released the latest AHC Foundation's Equine Economic Impact Study of the U.S. Horse Industry, that showcases trends related to economic impact, contributions to employment and the amount of acreage preserved in horse operations.

The total economic impact of equines in the U.S. increased by 45% from \$122 billion in 2017 to \$177 billion in 2022. Equine activities have significant impact beyond agriculture, encompassing tourism, entertainment, sports and recreation.


The industry's total employment impact increased by 33% from 1.7 million jobs to 2.2 million jobs over the five-year period.

The total population of horses declined from 7.2 million to 6.6 million, about an 8.5% decrease. To put this in perspective, in 1960 equines totaled about 3 million, the result of a steady decline after the turn of

the century when their use as transportation and farm labor diminished. Since the 1960s, the equine population steadily grew due to increased interest in Thoroughbred racing and in Quarter Horses being used as recreational mounts.

The AHC states the purpose of the survey is to demonstrate the value of the equine industry in national and state economies by analyzing the direct, indirect, and induced economic impacts of horse ownership, recreation, and equine-related services. The data collected informs public and private investments in equine-related businesses, equine health care, education, land use decisions, tax policy, tourism, employment incentives, etc.

"The Economic Impact Study is the most effective tool in our advocacy quiver," AHC president Julie Broadway said. "When the industry needs to take aim at an issue, this data is invaluable in helping us paint the picture of the contributions the industry makes and the breadth



and depth of its composition."

The American Horse Council Foundation also provided state and county level reporting, commissioned on a state by state or county by county basis. The Florida Thoroughbred Breeders' and Owners' Association funded reports for all equines, and specifically Thoroughbreds, within the state with a drilldown to the county level for Marion County, Fla. The results of these reports will be released in upcoming weeks.

Florida-breds Shine at Florida Cup



A premium Florida-bred racing event, the Florida Cup Day will be at Tampa Bay Downs racetrack on Sunday, March 24. Through a progressive partnership of Tampa Bay Downs, the Florida Thoroughbred Breeders' and Owners' Association (FTBOA), and HBPA, the finest Florida-breds in competition run for an estimated \$750,000 in purses. Gates open at 11 a.m. and the first race post time is 12:15 p.m. Races include the NYRABets Sprint for 4-year-olds and older at six furlongs, the Stonehedge Farm South Sophomore Fillies for 3-year-old fillies going seven furlongs, the Pleasant Acres Stallions Distaff Turf for fillies and mares 3-year-old and older going a mile-and-a-sixteenth, the Ocala Breeders' Sales Sophomore for 3-year-olds going seven furlongs, the Equistaff Sophomore Turf for 3-year-olds going a mile-and-a-sixteenth, and the Esmark Turf Classic for 4-year-olds going a mile-and-an-eighth.

The FTBOA also hosts their annual membership day. Membership is available to non-horse owners at ftboa.com. New members who join before March 15 can attend the event for free. Members receive complimentary admission, a buffet luncheon, refreshments and a racing program and can bring a guest. Children under 12 admitted free, additional adult tickets \$15 each.







New Cracker Horses and Cattle Book Released

Teacher and author Carol Matthews steps back in time to share preservation efforts of the living links to Florida's past, Cracker horses and cattle. The first horses and cattle to set foot on the North American continent stepped onto Florida land, brought by Spanish explorer Juan Ponce de Leon in 1521 just south of present-day Fort Myers. The animals were abandoned, formed wild herds and would be used by different

groups for food, work, trade and transportation for the next 500 years. Cattle ranching was born when Jesuit and Franciscan Friars, also known as missionaries, set up a system of missions across north and north-central Florida. The largest ranch was Rancho de la Chua, located on what is now Paynes Prairie in Alachua County. As a result of this increase in cattle production, Florida rancheros began to sell cattle to Cuba. This was the first industry to develop in the New World and would continue for the next 300 years. By the 1960s there were only a handful of pure cracker cattle and horses left. But herds were established on state lands, preserving a living link to Florida's past.

Carol Matthews taught elementary school for 40 years. A graduate of Ohio University, her love of history began at an early age when searching for arrowheads after the annual spring plowing of her father's cornfields. The last 17 years of her teaching career were spent in a small agricultural town in Florida called Indi-

antown in western Martin County, where she discovered an unlikely history mentor in the form of a spunky cattle rancher, well known in her circle throughout the state simply as "Miss Iris." Cracker Horses and Cattle is her third book on Florida history.



Racing Novice Class Offers Insider Look

Richard Dillon, is presenting 'Understanding the Racing Program at the Horse Track' as part of the Master the Possibilities programming on Thurs., March 7 from 10 a.m. to 11 a.m. at the On Top of the World classrooms in Ocala.

Dillon asks, "Did you ever go to the race track with friends who know how to bet and understand the racing form or program?"

He answers this by providing information for the casual bettor that will help fans understand the racing program and the included past performances of the horses and jockeys.



A retired Thoroughbred trainer and owner from the Northeast, Dillon operated a public stable for 18 years working with mostly claiming horses of various levels. He also rode for two seasons as an amateur jump rider at hunt meets in Maryland and has served as an adjunct professor at Wilmington College in Delaware.
